# **Indoor Sports Centre at St Ives High School**

## Joint Usage Project with the Department of Education

## **ADVOCACY STRATEGY**

#### **EXECUTIVE SUMMARY**

The objective of this document is to assist in the financial delivery of a four court indoor sports centre in the Ku-ring-gai local government area.

#### **BACKGROUND**

Ku-ring-gai covers the area from Roseville in the south to Wahroonga in the north and from St Ives Showground in the east to Lane Cove National Park in the west. Ku-ring-gai residents make up over 122,000 people with 46 per cent of parents with children.

Within the Northern Sydney Regional Organisation of Councils (NSROC) and the inclusion of the Northern Beaches, the most prevailing indoor sports centres for local and regional sporting codes are as follows; Thornleigh Indoor Sports Stadium (Hornsby Shire Council), Northern Beaches Indoor Sports Centre (Northern Beaches Council), North Sydney Indoor Sports Centre (North Sydney Council), Willoughby Leisure Centre (Willoughby Council) and the Ryde Sport and Community Centre (City of Ryde Council).

Currently, there are only a handful of half-court basketball courts within Ku-ring-gai which are situated on existing tennis courts or standalone features within parks. Community access to indoor or outdoor full court facilities is exceptionally limited and in most cases local residents are required to travel out of area in order to access these facilities and/or participate in the sport.

The primary community provider of basketball to Ku-ring-gai is the Hornsby Ku-ring-gai Basketball Association and stands as the fourth largest association in New South Wales. With current facilities over capacity (Thornleigh Indoor Sports Stadium) and no additional resources available, the overall growth of membership numbers and addressing the future needs of the association and the sport cannot be met.

Being a multipurpose facility, the indoor sports centre at St Ives High School will have the capacity to accommodate other community sports in addition to basketball including but not limited to netball, volleyball, badminton, indoor soccer, indoor cricket and table tennis. The extent of participation in indoor sports in the northern region and Ku-ring-gai specifically is totally dependent on the availability of suitable venues. Indoor venues are costly to provide and usually require financial input from several sources. The best way to describe the relationship of indoor sports and their participation rates is the distinctive phrase used in the film "Field of Dreams" — i.e. 'if you build it they will come'. As each indoor centre has been built, they have been filled to booking capacity within a short period of time.

The Joint Usage Project proposes a new four court indoor sports centre to be built on the St Ives High School site (Department of Education) with two courts being managed by Ku-ring-gai Council at

all times and two used by the school during school hours and managed by Ku-ring-gai Council after hours.

Funding is the major hurdle in the delivery of this Joint Usage Project with the Department of Education. Ku-ring-gai Council is committed to existing projects under the Delivery and Operational Plan and therefore has no available funds to contribute to the indoor facility. Provision of land and contribution towards two indoor courts from the Department of Education will require Council to source the additional funding to ensure a four court facility is achieved.

This advocacy strategy will endeavor to source the required funding from key target groups to ensure this opportunity is not lost to the local community and the greater region. As part of this process, Ku-ring-gai Council and key stakeholders will lodge grant applications where applicable to meet the financial target.

## AIM

#### AIM OF ADVOCACY STRATEGY

To ensure the opportunity for joint usage of indoor and outdoor facilities at St Ives High School is not lost. The Department of Education has provided an opportunity to participate in several Joint Use Facilities at St Ives High School, Ku-ring-gai High School and Lindfield Learning Centre. Due to financial constraints, Council is not in the position to participate in all available options rather prioritising and supporting 'in principle' the indoor sport centre at St Ives High School.

The Department of Education will be providing the land and will fund a two court centre. Ku-ring-gai Council currently have any available budget to commit to the Joint Use Project and will be seeking funding from external sources including the Department of Education to reduce Council's contribution to the total costs associated with building an additional two courts and the required car parking for the centre.

### **OBJECTIVES**

To make certain the funding decision makers (and those influencing them) choose to support the Indoor Sports Centre at St Ives High School – Joint Usage Project.

- Make them aware of the project & its importance
- Make them aware of the need for the project
- Make them aware of the potential wider local government reform implications of the project
- Make it an easy decision to support the Indoor Sports Centre at St Ives High School –
   Joint Usage Project and conversely an extremely hard decision to not support it

### **TIMELINE**

Deadlines for construction – 2020 (ready for the commencement of the school year)

Decision Date – Ku-ring-gai Council will prepare a report (to be presented at the Ordinary Meeting of Council on 27 February 2018) which will recommend that Council will further prioritise the joint use projects. This will mean that Council will not be seeking to pursue any works at Ku-ring-gai High School at this point in time, instead concentrating available resources at St Ives High School.

Council has engaged Otium Planning Group to develop a feasibility study for the indoor facility at St Ives High School. It is expected that this report will be made available by early March and used in a final report at the Ordinary Meeting of Council on Tuesday 27 March 2018 requesting a final decision regarding any financial contribution towards the project including the results from the advocacy strategy.

The Department of Education have indicated that their timeframe to commence design works for the indoor sports facility is imminent and therefore the likely outcomes of this advocacy strategy need to be quickly determined.
