#### **Terms of Reference**

#### Introduction

Ku-ring-gai Council (Council) owns and controls land to provide a range of services that benefit the community of Ku-ring-gai. Uses and values of land and buildings change over time and as a result, Council needs to undertake property development activities to renew existing assets and provide new facilities to meet the needs of its community.

The Councillors Major Projects Consultation Forum ("Consultation Forum") will provide an opportunity for constructive dialogue between Councillors, management and advisors on the current status of Major Projects and enable input to be regularly provided on key issues and challenges.

This Terms of Reference outlines the objectives, composition, authority and administrative arrangements of the Councillors Major Projects Consultation Forum ("Consultation Forum").

#### **Objectives**

The primary objectives of the Consultation Forum are to:

- Provide Councillors with oversight and transparency of development activities on Council owned or controlled land; and
- Enable a collaborative dialogue between Councillors management and advisors on key issues impacting Major Projects.

#### **Definition of Major Projects**

Major Projects are defined as:

- Any property development opportunity involving Council owned or controlled land with a value greater than \$5,000,000; or
- Property development projects designated as Major Projects by Council or the General Manager.

#### Composition

The Consultation Forum will be open for all Councillors to attend along with relevant members of management and key advisors as required. It will not be open to the public given the commercial in confidence nature of matters discussed.

#### **Terms of Reference**

The Consultation Forum has no delegation from Council.

The terms of reference for the Consultation Forum are to:

- Discuss and provide feedback on the annual Property Development and Investment Strategy prior to submission to Council for approval.
- Receive and discuss updates from Management and input from external advisors as required on the progress of Major Projects.
- Consider and provide feedback on the portfolio impact of concurrent Major Projects on Council services, staff and financial position.

#### **Meeting Frequency**

Consultation Forums will be held four (4) times annually. Additional Consultation Forums may be called by the Mayor or General Manager.

Due to the commercial nature of Council's Major Projects, unless otherwise indicated all information provided and discussions held in the Consultation Forum is confidential.


Attendees to each Consultation Forum must abide by the Code of Conduct and relevant policies adopted by Council.
