Minutes of the Guringai Tribal Link Aboriginal Corporation Annual General Meeting held at Point Clare is dated 25 November 2019 and provides very little information of their work in the local area. A search on the Registrar of Indigenous Corporations indicates that the Guringai Tribal Link Aboriginal Corporation function is Cultural Advisors with an income of \$47,224 for the financial year ending 30 June 2018.

There is insufficient information supplied in this application to make an assessment supporting funding for this project and the benefits to the local area.

ORGANISATION BACKGROUND:

KU Fox Valley Preschool is a small preschool nestled in a beautiful bush land setting in council owned premises on Fox Valley Road, Wahroonga. We are part of the larger not for profit organisation, KU Children's Services with a long history of active community involvement, having celebrated our 50th birthday in 2018 with the Mayor in attendance at the event. Our stimulating, natural hands-on learning environment brings out the curiosity of children, extends their thinking and equips them ideally for a successful transition to school. One of the best things about KU Fox Valley is the sense of community that is fostered here. With frequent opportunities for families to contribute to the program they gain a sense of belonging through participation and we enjoy local connections with Greenwood aged care and Wahroonga Waterways Landcare. We aim to provide a high quality preschool experience and in doing so make lasting community connections, promoting connectivity and social capital, benefiting children and their families. Our objectives include developing genuine, reciprocal relationships within our community, drawing on the skills, experiences and inspirations of our parent community and staff. Meaningful, hands-on. relationship-based naturalistic learning for children is a key objective in achieving this.

AMOUNT REQUESTED: \$2,160

PROJECT DESCRIPTION:

Aunty in Residence enrichment – In term 1 2020 we wish to host an Aunty in residence period, where Aunty Caressa, an Aboriginal Aunty sourced through local organisation Koori Kinnections will work with both our groups of children. The Aunty in residence was an innovation we began in partnership with Koori Kinnections in term 1 2019. We learned through this engagement the value of Aunty Caressa's involvement. The 2020 project will be a modification of the project in 2019 and will take place over a 3-week period, with 2-hour visits with each group planned in a format that builds on our prior experience. The children who were in attendance in 2019 will revisit their learning with Aunty Caressa again and as she is now familiar with our centre and the staff we anticipate this to be a deeply meaningful engagement. A new group of children will also have the benefit of learning with her for the first time. The outcome of this residency is to work with the children in a hands-on way, whilst engaged in our learning program, exploring Aboriginal histories, bush foods, traditional games and aspects of culture, in line with the children's interests.

In 2018 we celebrated our 50th birthday and also formed our first Reconciliation Action Plan (RAP). Through this project we developed our own Acknowledgement of Country and we honoured Mother Earth. With hands on learning connected with the Early Years Learning Framework, the curriculum, we anticipate the preschool community will benefit from a deeper knowledge and respect for the land, native plantings and Aboriginal customs and practices.

ORGANISATION BACKGROUND: The Cathedral Singers (TCS) is a mixed adult choir originally formed in

1998. TCS's ministry is unique in the Sydney region is to provide high quality cathedral style music in churches of all denominations, to enhance worship and maintain the church music tradition. TCS is a choir in residence at the Anglican church of St John the Evangelist at Gordon and sings regularly in church services in a variety of Christian churches as well as nursing homes, weddings, funerals and community events. TCS travels to other parts of New South Wales for weekends once or twice a year.

Choristers enjoy the social, intellectual and psychological benefits of four and six part choral singing. Although TCS is an auditioned choir they welcome any potential members and actively seek new singers. Their current musical director is Pittwater House School.

TCS offer choral and organ scholarships and although no-one currently holds one, the choir regards mentorship of young musicians as an important part of their mission.

AMOUNT REQUESTED: \$3,000

PROJECT DESCRIPTION: Choral workshops, new music

Workshops: In recent years we have undertaken a number of choral workshops. These have been led by different experienced music directors and vocal teachers who have worked with us on such things as pitch, rhythm, sight reading skills and musicianship. These have been extremely useful for polishing well known repertoire, mastering new and difficult pieces, and improving singers' skills more generally.

Guest organists: Our music director has a dual role of conductor and organist. On occasion we invite a guest organist to accompany us. This allows us to work with talented musicians and frees our music director to concentrate on conducting.

Music library: We have a library of scores and sheet music but are keen to purchase new pieces to keep our repertoire diverse and interesting for both audience and choristers. In addition, some well-loved copies are now torn or deteriorated and require replacing. We require 20 copies of each item.

Workshops allow us to improve the quality of our performances, as does working with guest organists. We need music that is in good condition in order to sing accurately and well.

ORGANISATION BACKGROUND: StreetWork is a not-for-profit, community-based organisation that focuses

on prevention/early intervention strategies delivered to 'at risk' young people (YP) so that they have the same opportunities as their peers – that is to grow, to achieve their dreams and to develop as a person with high self-esteem. StreetWork's mission is to provide innovative and effective services for medium-high 'at risk' YP aged 11-18 affected by crime, mental health issues, violence, homelessness, social isolation, alcohol/substance misuse, those disengaged from school/education or with poor employment

opportunities, to turn their lives around.

StreetWork has close to 40 years' experience working with 'at risk' YP, acting as a "specialist concierge" to connect YP to specific youth services providers such as Juvenile Justice, employment agencies, education and counselling services. Our aim is to assist 'at risk' YP to tackle the core problems they face, working to reinstate their self-esteem and self-worth by providing the best level of support possible. The organisation has three branches servicing Sydney's North Shore, Northern Beaches and Hornsby/Ku-ring-gai communities. StreetWork employs 9 full-time, part-time and casual staff members and has more than 310 volunteers.

PROJECT DESCRIPTION:

Urban Art – Urban Art helps 'at risk' young people (YP) to develop aerosol and contemporary art-style skills in a safe and legal environment. Urban Art classes are held weekly in Chatswood however StreetWork is looking to expand the program to its Hornsby/Ku-ring-gai branch. The program focuses on the design and development of a YP's skills across

various styles including stencilling and decorative lettering.

StreetWork's programs focus on stabilising and reducing a YP's risk of being involved in youth crime, and of suffering from a mental illness or suicide, of being homeless and for early school leavers for not being in employment. By taking a holistic approach that addresses risk and protective factors, StreetWork is better positioned to alleviate disadvantage and promote general wellbeing among YP. Central to the success of StreetWork's program is the tailoring of service delivery to suit the YP's risks, needs and responsiveness factors.

The key social benefits of Urban Art include:

• Improved youth engagement with services/programs in the local area.

• Providing an opportunity for socially isolated YP who are already engaged with StreetWork, to interact in a structured, safe program and have fun with other YP.

- give children and young people access to the highest quality art, artists, experience and process

PROJECT DESCRIPTION:

Common Ground - FORUM – Culture made to be consumed by adults is everywhere. But what, and where, is the culture for young people?

MSTYP proposes to host a series of three community activation forums. They will be contemporary town square meetings, bringing together people from differing backgrounds and experience to eat, to listen, to share and to speak.

These will be facilitated round-table conversations where 7 participants will be invited to:

- Bring a plate to share for afternoon tea
- Present a 3 minute talk on their practice, story or agenda, and how they contribute to the cultural landscape
- Participate in a facilitated conversation, answering a series of facilitated questions on youth and children's culture
- Have their conversation documented by an artist, and present a short response at the end of the round table

We seek to articulate some of the cultural forces at play in Ku-ring-gai. By the end of this series we will have begun a meaningful dialogue in our community around issues relating to young people, helped to promote social cohesion and wellbeing, and launched a conversation about the culture our young people want to inherit, covering such topics as:

- Where does Ku-ring-gai sit in this national and international conversation?
- Are we social leaders or followers?

The Common Ground forum will enable young people to have a voice in the future of their culture. The round-table platform will give young people a way to engage with meaningful, relevant cultural concepts, and to challenge community and cultural leaders to hear them.

There are few platforms for adults to discuss the future of culture for

children and young people. There are even fewer opportunities for young people to be involved in them. We believe that the voice of children have the power to change the world, so let's help them.

The project will also help create art, where at each session we will invite an artist from a different discipline become 'resident' for the session, and to present at the end of the forum a short piece. We will engage three artists: a poet, a theatre maker and a composer to create these artistic responses to the discussions.

We are proposing to cover the MSTYP staffing costs for this project, where Council covers the incidental costs such as venue hire and sound.
