Thank you for submitting the generic draft Plan of Management (PoM) for General Community Use Community Land and Crown Reserves on 21 February 2023.

I have reviewed the draft PoM and support it being placed on public exhibition with the following amendments:

- Correct reserve number R10007 in 8.2 Community Spaces to R100073.
- Amend lots in Appendix A for R91141 to part lot 478 and part lot 7312 in ID 275 on page 35.
- Amend lot 7311 DP1158394 in R500217 to part lot in Appendix A.
- Remove duplication of R88493 in Appendix A it is included in lot information for R86634 on page 43 and also on page 37. R86634 should only be part Lot 825 DP 752031.
- Correct reserve number R500214 in Appendix B page 54 to R500217.
- Include tenure information about Killara Park Kindergarten as it is listed in 8.2 Community Spaces and has a substantial privately run child care on this reserve.
- Insert amended Map 23 for R86634.

Council should conduct a final review of the document to ensure all legislation referenced is currently in force, departmental names are up to date, and spelling, grammar and formatting is correct and consistent.

Subject to no changes following public exhibition, as a delegate for the Minister for Lands and Property, I consent to council to adopt the PoM under clause 70B of the Crown Land Management Regulation 2018.
